Eisenberger & Herzog advises VMS on the sale of personnel service providers to Synergy Employment Solutions

The REB II affiliates ("VMS"), advised by VMS Value Management Services GmbH, as well as the Völker private foundation, sold 80% of the personnel service provider Völker GmbH to the Spanish Synergy International Employment Solutions SL, a 100% subsidiary of Synergy SE, listed in France. Eisenberger & Herzog advised the transaction for the seller, led by partner Marco Steiner and senior associate Sasa Stojanovic.

Synergy ranks fifth among the largest temporary employment agencies in Europe and generated sales of approx. EUR 2 billion in 15 countries. 20% of the shares remain with the Völker private foundation. The transaction is subject to the approval of the competition authority. Silence has been agreed on the purchase price.

The Völker GmbH was founded in 2006 by Martin Völker (CEO) and is one of the leading temporary employment and personnel services companies in Austria after 10 years. A majority stake was acquired by VMS in 06/2011. Under the leadership of VMS, the company has been able to triple its turnover, branches, number of employees and operating profit within 6 years.
